REACH Substances of Very High Concern

Dear Customer,

The following information is provided in response to your request for INEOS's Composites position concerning the presence of Substances of Very High Concern (SVHCs) in the products we manufacture, market and sell to customers in the European Union (EU).

INEOS Composites can confirm that:

- Procedures are in place to ensure compliance with the REACH obligations of a supplier for proactively and reactively informing our customers in situations where SVHCs are present in our products. Additionally, as a general rule, INEOS Composites will provide you with the latest version of the Safety Data Sheet (SDS) upon product purchase. If an SVHC is present in any of the products you purchase from INEOS Composites, the substance will be listed on the European SDS (at "any known concentration" equal to or greater than 0.1 %).
- The current INEOS Composites Performance Materials portfolio does not contain an SVHC substances at 0.1% or higher.
- Where applicable, you will see these substances identified on the European SDS for the product. Although not legally required, INEOS Composites is working on the reformulation of (some of) these products, where there is a benefit from reformulation to INEOS Composites and our customers. In specific cases, you may be contacted to review the options.
- As additional SVHCs are placed on the candidate list, we will review the formulations of our product portfolio
 to phase out these substances from our products, where possible.
