

Privacy Statement - China Addendum

In addition to the privacy statement of INEOS Styrolution as issued on its website from time-to-time ("**Privacy Policy**"), the following terms in this China addendum ("**China Addendum**") apply to the personal data that is collected and processed by INEOS Styrolution Polymers (Shanghai) Company Limited and its affiliates in China (see Appendix I to this China Addendum) (collectively "**Company**" or "we", "us" or "our").

This China Addendum supplements the Privacy Policy. The China Addendum needs to be read in conjunction with the Privacy Policy.

1. Collection and Use of Your Personal Data

We collect and use your personal data in accordance with Section 3 (Business Partners (Suppliers, Customers)), Section 4 (Marketing), Section 5 (Applicants) and Section 6 (Websites) of the Privacy Policy.

2. Sharing of Your Personal Data with Third Parties

We will not provide your personal data to third parties in violation of law. For the purposes stated in the Privacy Policy and this China Addendum, we may share your personal data with our affiliates located outside China (please see Section 3 below), to the extent that such disclosure is necessary to provide you with our services or products.

3. Cross-border Data Transfer of Your Personal Data

We may process your personal data outside of China for the purposes set out in the Privacy Policy and this China Addendum. Our data transfers to our affiliates and to third party service providers located outside China will be in accordance with applicable data protection laws, including but not limited to PRC laws and regulations.

You may check the name and contact information of the overseas recipient, the purpose and method of processing, the types of personal data processed and how you can exercise your rights as a data subject by referring to the following list of overseas recipients:

4. Data Subject Rights

You may exercise the following rights regarding your personal data that the Company collects and processes:

(1) Right to access and obtain a copy of your personal data

You have the right to request that we provide you with access to or a copy of your personal data unless otherwise specified by applicable PRC laws and regulations.

(2) Right to rectification

If your personal data is inaccurate or incomplete, you may request that we update and rectify your personal data.

(3) Right to erasure

Under the following circumstances, you have the right to request us to delete your personal data (i) if the purpose of processing has been achieved, is impossible to be achieved, or it is no longer necessary to achieve such purpose of processing; (ii) if we cease to provide products or services to you, or the retention period for personal data has expired; (iii) if you withdraw your consent (if consent is the basis of processing); or (iv) if we process your personal data in violation of applicable PRC laws, administrative regulations or the agreement with you.

(4) Right to Restrict or object to processing of your personal data

You have the right to restrict or object to our processing of your personal data. You also have the right to request an explanation about the rules of processing your personal data from us.

(5) Right to withdraw consent

If we rely on your consent to process your personal data, you have the right to withdraw consent to future processing at any time.

(6) Right to request explanation

You may request that we explain how the Company processes your personal data.

(7) Right to portability

You have the right to request that we transfer your personal data to entities appointed by you in accordance with the requirements as set out under applicable Chinese law.



5. Children's Personal Data

We will not offer products or services to minors under 14 years old. We will treat minors' personal data as sensitive personal data and comply with relevant rules on sensitive personal data under applicable data protection laws, including but not limited to PRC laws and regulations.
