## **GB REACH compliance**

Dear customer.

We are pleased to confirm that our products sold to the GB market comply with GB Reach regulations, as to ensure that the supply of goods to our customers is not disrupted.

Our current intention is that we will notify through DUIN to HSE all the substances that INEOS Composites manufactures and exports to GB prior to the deadline. We are also working with our suppliers to ensure that they will notify and ultimately register. While it is our intention to ensure registrations for substances exported to GB, we cannot guarantee or absolutely commit to future registrations. INEOS's Composites portfolio is subject to continual evaluation and optimization based on the market and customer needs, including market size and profitability.

To avoid our customers importing INEOS Composites products from INEOS Composites into GB having to notify/register substances involved, INEOS Composites has appointed "Ineos Composites Ltd" as their Only Representative (OR) per GB Reach Regulation. Notifications and registrations will also be completed under GB Reach by our OR, where applicable. When the registration phase starts, we will establish a relationship with customers importing from INEOS Composites which will relieve them from their registration obligations as an importer and become a downstream users of INEOS Composites under GB Reach.

### Non-GB Customers

INEOS's Composites non-GB customers exporting their products within the scope GB Reach to GB must ensure that their GB-based importer will notify under HSE any of the relevant substances or monomers which are imported at levels over one metric ton per year. INEOS Composites does not cover third-party imports through an INEOS Composites Only Representative.
