E101 = valid document available, 2 pages, signed and dated, for employee whose employers are domiciled in the EU but not in Belgium. wp = work permit for non-EU residents rno = registration number for an independent person registered in Belgium One A4 copy of these documents must be handed in at the Southern Entrance. The applicant has to keep a copy of the documents in his possession.</p> <p>(2) Language requirement: in each group working in close proximity and line of view, at least one person must be able to speak the language of every person in the group AND be able to speak at least one of the following languages: Dutch, English, French or German.</p> <p>(3) The contractor shall sign in all persons who, in terms of the agreement (contract) that he has with the principal and/or purchaser, come to work on the site of INEOS and shall carry the full responsibility to ensure that all information provided are correct. If subcontractors are used, the contractor shall also sign in the persons working for subcontractors and provide guarantees to the contractor that the information provided with regard to these persons is correct. In case of possible checks by the authorities, the contractor shall upon request present the required documents to verify the correctness of the information provided.
